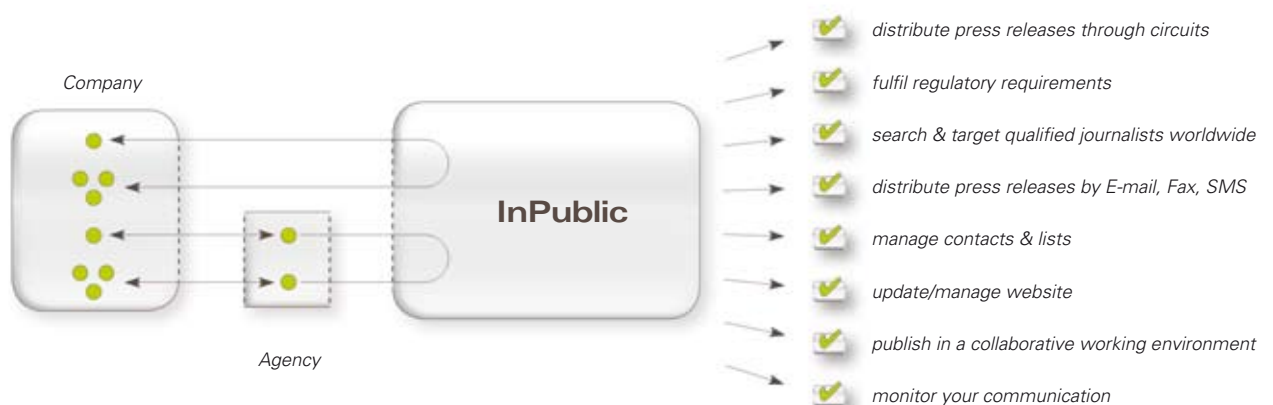

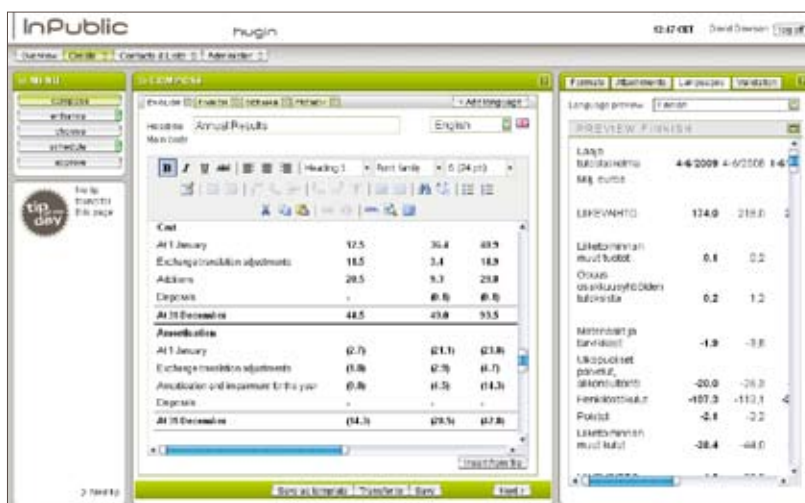

An analysis of exceptional items is set out on page 4. Exceptional items relate to realised losses and unrealised net gains on investment capital, redundancy costs and the impairment of intangibles associated with acquisitions.

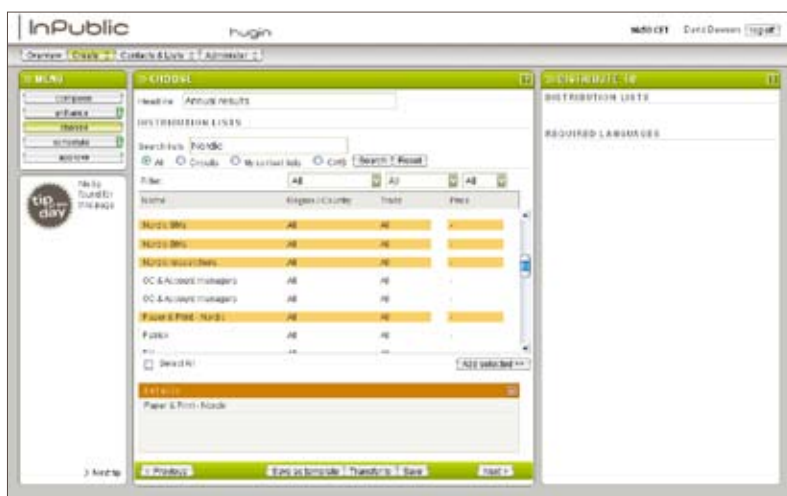

In addition, at the time of its distribution, regulatory information must be filed with the local competent authority and archived with an Officially Appointed Mechanism. In most cases, the information also needs to be filed with the stock exchange(s) this company is listed at. Whether you are a company listed on one or multiple markets, InPublic helps you meet all your disclosure requirements under the EU Transparency Directive. Hugin has integrated solutions to fulfil regulatory requirements in 13 European countries and can file your release with 27 stock exchanges.
